Every application for accreditation must be accompanied by a digital photograph of the applicant. Organisations should note that accreditation cards cannot be produced without an approved photograph that meets the following required specifications.

- Photographs must be taken with a white or light-coloured background, without any shadows.
- Photographs should show recent likeness of the individual (preferably taken within last six months).
- The applicant should:
  - be the only person in the photograph;
  - face forward and look straight into the camera;
  - have a neutral facial expression and mouth closed (e.g. no smiling, grinning or frowning); and
  - have their eyes open, visible and free from reflection or glare from glasses.
- The applicant should not:
  - have anything covering their eyes or face (e.g., hair or glasses frames);
  - wear sunglasses or tinted glasses;
  - wear a hat or cover their head unless for medical or religious reasons;or
  - take a 'selfie' picture.
- Digital photographs should:
  - be stored in jpeg (.jpg) format;
  - have a file size of 50–300 kB (kilobyte) – larger files will be rejected; and
  - have a portrait orientation with an aspect ratio of 4×5.

Some examples of photographs that would be approved and rejected are shown on the next page. The rejected photographs include an explanation of why they would be rejected.
